

Certified Surgical Foot and Ankle Coder

The Certified Surgical Foot and Ankle Coder (CSFAC) exam (www.apma.org/csfac) was developed by the American Academy of Professional Coders (AAPC) in cooperation with APMA to provide a means for professional coders, podiatrists, orthopedists, and billing staff to demonstrate their expertise in coding medical services and surgical procedures performed on the foot and ankle. Ankle Foot Orthotics – Carrier Activities

In February 2013, the DME MAC Jurisdictions announced that the AFO policy article, effective January 1, 2013, was being revised to remove the height restriction. These actions come after a concentrated effort by APMA's DME subcommittee and outside stakeholders to reverse the new height restrictions. APMA believes the change to the height requirements was not backed by scientific evidence and therefore was inconsistent with the devices

many members prescribe. APMA continues to monitor recent AFO activities, including questions about specific Medicare coverage for the use of an ambulatory AFO for fall prevention as well as changes to LCD policies as those listed above. In the former issue, APMA has posted a Coding Alert on the website regarding the guidelines for AFO use.

TRICARE

On August 8, 2013, the U.S. Department of Defense (DoD) released a proposed rule that will allow DPMs to prescribe and dispense DME to TRICARE patients. It would end an unevenly administered policy and a disparity faced by podiatrists that APMA has long fought to overturn. APMA has been in contact with the DoD and TRICARE Management Activity (TMA) for more than five years in an effort to change this policy. APMA also has lobbied Congress to put pressure on DoD and TMA to end this disparity. Despite the long process, APMA is pleased with an end result that will

recognize podiatrists as eligible providers of DME under TRICARE.

Diabetic Therapeutic Shoe Update

On April 25, HR 1761, The Helping Ensure Life- and Limb-Saving Access to Podiatric Physicians (HELLPP) Act, was introduced in the 113th Congress by US Rep. Lee Terry (R-NE). HELLPP Act includes multiple comprehensive reforms and goes further to ensure podiatric physicians will continue to save lives, limbs, and health-care dollars. The HELLPP Act will clarify and improve coordination of care in Medicare's Therapeutic Shoe Program for Patients with Diabetes. As part of this effort, APMA's health policy committee and APMA's health policy consultant helped create a provision that would clarify the role of a prescribing podiatric physician in terms establishing medical necessity, consequently ease the reporting burden on all physicians involved in the TSD program.

Routine Footcare Activities

APMA met with CMS in Baltimore in 2013 to address routine footcare activities. Previously, APMA and HPC staff approached Kathleen Bryant, Director, Division of Practitioner Services, Hospital and Ambulatory Policy, CMS, for an update on the status of APMA's request for revisions to the Medicare Benefit Policy Manual, Section 290. APMA through HPC submitted a request for revision, as well as a draft version, and has met with CMS regarding this request. Ms. Bryant requested additional materials from HPC, which were provided. In addition, and with the assistance of APMA's health policy consultant, APMA developed a side-by-side comparison of current Medicare policy and our recommended revisions, along with related explanatory comments to facilitate further CMS consideration of APMA's proposed changes to the manual.

Provider Non-Discrimination Provision

Included in the ACA is an important provision protecting DPMs from discrimination by health insurers. APMA and its partners in the Patient Access Responsible Care Alliance (PARCA) successfully lobbied for its inclusion and are now working together to safeguard retention of section 2706, titled "Non-Discrimination in Health Care. APMA continues to monitor all repeal efforts by Congress to ensure that this provision remains in effect. APMA is also seeking to prevent any weakening of this provision by CMS and is currently responding to a CMS request for more information.

Physician Payment Sunshine Act

The Physician Payment Sunshine Act (PPSA) requires drug and medical device companies to report publicly payments and other gifts made to physicians, including podiatrists. It also requires companies to report information on ownership or investment interests held by physicians.

Members should be aware that companies began collecting data on August 1, 2013 and submit their first reports to CMS by March 31, 2014 for the August-to-December 2013 reporting period. Members should record payments and other gifts received from companies to check the accuracy of the companies' reports. Once CMS announces the method for physicians to check the accuracy of their data, APMA will disseminate this information. Physicians' data will be posted on a available publicly on-line database September 30, 2014. HIPAA/HITECH Act

As a reminder, the final rule modifying the HIPAA Privacy, Security, Enforcement, and Breach Notification Rules, issued by the HHS Office of Civil Rights, required compliance on September 23, 2013 for covered entities and business associates. APMA's HIPAA resources, located at www.apma.org/hipaa, include templates for summary of notice of privacy practices, business associate agreement, risk analysis checklist, and many more.

Recently, the CPA has assisted KSPMA, HPMA, and SCPMA in their scope of practice state advocacy efforts by providing letters of support, fact sheets, myth busters and statistics.

eAdvocacy

Financial and Administrative Alignment State Demonstrations for Dual Eligibles

CMS partnered with 15 states to coordinate care for dual eligible beneficiaries through state demonstrations. The purpose of these state demonstrations is to identify and validate delivery system and payment coordination models to be tested and replicated in other states.

The financial alignment models being tested are the capitated model and the managed FFS model. The CPA has been engaged with the CPMA and IPMA who are concerned about podiatrists continuing care for their patients due the capitated model's passive enrollment feature.
