- 1. **Statement of Purpose:** Program is for scientific and educational purposes only and will not promote the Company's products, directly or indirectly.

The Company agrees not to direct the content of the program. The Company, or its agents, will respond only to Sponsor-initiated requests for suggestions of speakers or sources of possible speakers.
